Engagement

SKP was appointed by a European company to conduct financial due diligence on an Abu Dhabi-based target company having presence in the Middle East and India into non-destructive testing (NDT) services for the oil and gas industry.

Our Findings

- Performed adjustments to revenues for non-operating income concerning sales of assets, dividends received, interests, etc.
- Found an increase in direct expenses for assets purchased as expenses, while they should have been capitalised.
- Undervalued inventory in earlier years. The necessary addition was made to show the correct value of inventory for FY 2009 and 2010.
- Fictitious purchase and expense bills were debited in the books with the sole objective of removing profits from the business. These were paid for in a cash-management adjustment.
- Cash flows did not show the true picture due to the lower inventory valuation in earlier years and cash withdrawals done by the management through fictitious purchase and expense bills.
- Entity in India used to take loans and there were chances that the Indian tax authorities could treat this as income exposing the Indian entity to tax liabilities.
